Approve Resolution #2017-06 and Resolution #2017-07 setting the Basic Salary Schedule for fiscal year 2017/18 and authorize the Chairman to execute related documents.

#### **ALTERNATIVES:**

None.

#### BACKGROUND:

The District Board approved a salary increase of 1.0% effective 07/01/17 and a 6.75% increase effective 10/01/17 for the District Employees. These increases have been partially off-set by the CalPERS Classic employees picking up the 8% Employee Paid portion of retirement costs.

Resolution #2017-06 and Resolution #2017-07 have been prepared contingent upon the approval of item 3 requesting the approval of the APCO Agreement.

### FISCAL IMPACT:

The current proposed budget includes a 6% (\$46,522) increase in salaries to accommodate the Employee and District agreement salaries. Subsequent to the negotiations with staff, the District Board approved an increase in the management employee salaries that matches the salary increase percentages negotiated with staff. Additionally, there is a proposal before the Board at today's meeting regarding the APCO's Agreement that would include an increase in the APCO's salary matching the percentage increases negotiated with staff and management personnel.
